## Telephone Meeting of the Executive Committee February 4, 2013

The meeting convened at approximately 5:00 p.m. after all participants were connected for the conference call. The participants included members of the Executive Committee (Randall Donaldson, Cynthia Halpern, Joan Marx, Leslie Sconduto, and Phillip Wolfe) along with the Administrative Director Roz Macken.

1. The minutes of the November 11, 2012 Telephone Meeting were approved. (5-0)
2. **Budget:** P. Wolfe reported that the investments in Illinois are proceeding as expected with a probable \$2,000 profit projected. R. Macken reported that there are no additional expenditures that are expected.
3. **Administrative Director's Report:**
  - **Forum:** R. Macken reported that she expects a 50 page *Forum* this year given the great number of submissions that she received, especially from students. Furthermore, she expects it to be not only the biggest issue ever, but the best and credits the new Editor, Kajsa Larson, from Northern Kentucky University for these changes.
  - **Elections:** Secretary and First Vice-President will be up for next year. R. Macken will consult with the Elections Committee.
  - **Recruitment: Foreign Chapters:** R. Macken presented information from ACHS regarding the practices associated with international chapters. The Board agreed that the comments provided were helpful in informing PSI of the pertinent issues involved in such a venture.
4. **PSI Chapter Applications:** The Board unanimously approved the Chapter Application from Harding University (5-0).
5. **Scholarship Committee:** C. Halpern reported that Maria Rippon of Furman University agreed to serve as the new Acting Chair of the Scholarship Committee. Mirna Trauger from Muhlenberg College will also participate on the Committee. The Board again reaffirmed the date for submission of scholarship applications: March 29, 2013. P. Wolfe suggested that PSI send a formal letter of thanks to the participants on the Scholarship Committee. His motion was unanimously approved (5-0).
